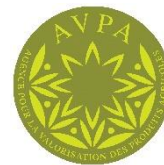

3. The member will deliver before February 28th, 2021 a minimum of 4 commercial units (10 cl bottles minimum) of each edible oil entered in the contest. The member is responsible for their correct packing for a safe delivery to the AVPA headquarters.
4. When the contest results are announced, the signed certificates are sent by email; original paper certificates will be delivered to the laureate members who come in person or will be sent by courier, the cost of it being charged to the laureate.
5. After the contest, the laureate member acknowledges AVPA's right to use his information and products within relevant events and training periods, and agrees to join this promotion effort by sending for each awarded oil:
 - a. All the necessary information and pictures to publish a presentation of the product and its producer.
 - b. At least 2 packs of edible oils in commercial units (10 cl bottles minimum) .
6. The laureate member is entitled to show the AVPA distinction on the package of the awarded product, according to the licence provided by AVPA, which shall be signed for the distinction to be used.
7. The member declares he has read the statutes of the association and the rules of procedure, to which he agrees without restriction or reservation. As such, he waives any recourse against the organizer AVPA, who declines any liability for error or omission.
